## Copyright Infringement Policies and Sanctions (Including Computer Use and File Sharing)

Any sharing of copyrighted material without proper licensing or permission from the owner/author/software manufacturer is prohibited by law, and is not condoned by institutions. Any students accused of copyright violation or infringement will be required to resolve matters on their own without involvement from the institutions.

### **Summary of Civil and Criminal Penalties for Violation of Federal Copyright Laws**

Copyright infringement is the act of exercising, without permission or legal authority, one or more of the exclusive rights granted to the copyright owner under section 106 of the Copyright Act (Title 17 of the United States Code). These rights include the right to reproduce or distribute a copyrighted work. In the file-sharing context, downloading or uploading substantial parts of a copyrighted work without authority constitutes an infringement.

Penalties for copyright infringement include civil and criminal penalties. In general, anyone found liable for civil copyright infringement may be ordered to pay either actual damages or "statutory" damages affixed at not less than \$750 and not more than \$30,000 per work infringed. For "willful" infringement, a court may award up to \$150,000 per work infringed. A court can, in its discretion, also assess costs and attorneys' fees. For details, see Title 17, United States Code, Sections 504, 505.

Willful copyright infringement can also result in criminal penalties, including imprisonment of up to five years and fines of up to \$250,000 per offense.

### Sexual Harassment Policy

The Department of Education prohibits an institution from including in the On-Time Graduation Rate a graduate who may have taken a leave of absence, graduation was delayed due to school closing for bad weather, or changed their original enrollment schedule. It has always been the policy of Hair Design Institute to try to accommodate requested schedule changes and documented leave of absences. Students who fall into this category, although they graduate, do not meet the definition of an on time graduate and are not included in this rate.
